CAAT Training Due September 30

The fall online Child Abuse Awareness Training (CAAT) is due from all LAUSD employees on September 30th. If you have not yet completed this training, you must do so before the deadline. Remember, this training is mandated by the Federal government and the District. If you need any help accessing the training online, please speak to your site administrator.

Apply for Financial Aid



The beginning of the annual college financial aid application season starts on October 1st. The free Application for Federal Student Aid, more commonly known as the FAFSA, is available for the 2018-2019 school year beginning today, October 1. Filling out the FAFSA is required to access any of the billions of dollars that get handed out each year in college grants, loans, and work study awards.

This is the second application cycle since the U.S. Department of Education moved up the financial aid timeline by three months. The process of applying will actually look different hen in previous years, thanks to some security updates that were made to an online tool designed to ease the process of filling out the form. Here are some tips to be successful in applying.

First: Everyone should file a FAFSA.

Every student who is considering college next year should fill out the FAFSA. Even if you don't think you'll qualify for federal grants, most states and many colleges also use the form to award grants and scholarships. And it's required to take out any federal student loans, which are cheaper and safer than private market loans.

Second: Get organized.

Start by creating an FSA ID, and before you begin filling out the form at fafsa.ed.gov, gather your 2017 tax return and W-2 forms and current bank statements. This year you'll be using 2017 tax information to apply for the school year that starts in the fall of 2019.

Third: Pay close attention to various deadlines, and submit the form as early as possible.

Procrastinating can cost you: While federal grants won't be affected by the date you file, some states and colleges give out limited award money until it runs out. Pay close attention to "priority deadlines" on college websites, as well as those for state and agency programs.

California Dream Act Application is available as an alternative means to pay for college education in California for eligible undocumented students. Undocumented students should not complete the FAFSA, but instead complete the California Dream Act application at <u>caldreamact.org</u> and follow the same tips for success.



Reminders for all Staff

Single Sign on For Adult Students

You have all heard the news by now. All adult education students in DACE are getting Single Sign-On (SSO) accounts! The main benefits for NVOC students is that all will have:

1) an LAUSD email account

2) a Google Drive account and can create Google Documents3) an Office 365 Account AND access to Word, Excel, Power-Point, etc. for their home computers

4) Schoology accounts and access to other programs (e.g. Burlington English, Edmentum, and APEX) using their SSO to sign in.

Informing our students and helping them start to use their new SSO accounts and LAUSD email addresses will be a school-wide project commencing September 17 and lasting 4 weeks. Teams of NVOC teacher advisors will be visiting all classes at each site to inform students and help them activate their new SSO accounts, develop passwords, and learn the basics of using them to log on to a website, complete a task such as fill out a Google Form, and send an email.

More details about the schedule of classroom visits will be forthcoming. Please pay attention to your email messages and posted announcements at your sites for details. We hope that you will welcome the Teacher Advisors to your classrooms, and encourage your students to activate and use their new LAUSD email addresses and SSO accounts on a regular basis.

As the school year progresses, further Professional Development on ways to manage your students' SSO accounts, set up on-going communication with your students via their new LAUSD email accounts, and ways to help your students access all of the benefits of having SSO accounts will be provided.
