#### What does CCRS stand for and what is its purpose?

"The integration of CCR standards into adult education programs is intended to provide all adult students with the opportunity to be prepared for postsecondary training without needing remediation. To that end, the CCSS selected for inclusion here identify *beginning levels* of study, reaching students at their instructional levels upon program entry and positioning them for successful progress toward college and career readiness."

#### What does ELPS stand for and what is its purpose?

"The English Language Proficiency (ELP) Standards for Adult Education (AE) are intended to address the urgent need for educational equity, access, and rigor for adult English language learners (ELLs). States are adopting challenging academic content standards for adult education with the goal of ensuring that adult learners are adequately prepared for careers and postsecondary education."

# **NVOC Students to Compete in SkillsUSA**

Time is ticking away as NVOC students get ready for SkillsUSA regionals! With over 58,000 students up and down the state enrolled in the organization that promotes leadership and career technical education training, California has the largest number of students involved with SkillsUSA, Last year, eight CTE students represented North Valley at the SkillsUSA regional conference and skills competition, with five placing in their division. It was NVOC EMT student Amanda Goldberg who was named state champion and represented California at the national championships.

This year, 11 NVOC students have agreed to represent the school in their CTE area as they vie for gold, silver, and bronze at the SkillsUSA regional competition in January at Pierce College in Woodland Hills. From automotive to electrical, welding to healthcare, we are looking for more students to participate in SkillsUSA.
