Message from the Principal

orth Valley Occupational Center offers quality courses in Academics, Career Technical Education, and English as a Second Language. Our courses are short term, low cost, and accessible day and evening. Though we may have great programs and quality teachers, enrollment has dropped school and district wide, resulting in a shift of focus. We no longer place as big of an emphasis on filling classes as we did in the past. What we do focus on are two things: completers and student persistence. How they affect each other? Student enrollment persistent will result in student completers. We know this connection, now we have to ask ourselves important questions that will help us address declining enrollment. Let's consider some questions.

- 1. Why are students coming to school?
- 2. What keeps students wanting to come to school?

3. How do we make connections between student personal goals and DACE curriculum?

The fist two questions can be answered by asking students and should be part of an ongoing conversation. The third question is a reflective question we ask ourselves as educators. How do we make connections with students? Any teacher will know answers will vary, as student goals vary. We must know who our students are and why they are coming to class. Then we must tailor the delivery of instruction to student needs. Perhaps students will say they need more modeling, practice time, or
